NOTICE

All concerned are hereby informed that Public Sector Students, registered prior to Winter Session 2018 have been allowed three attempts for qualifying PIPFA Examinations under PIPFA Public Sector Syllabus-2015.

The students of Public Sector will appear in the winter 2018 examinations as per following arrangements;

1. The nominees of AGP, PMAD, PRAD, Treasury Department (PG) and other government organizations who registered **prior** to Winter Session 2018 are granted three (03) attempts (i.e. Winter 2018 to Winter 2019) for qualifying PIPFA Examinations under the old syllabus-2015. From session Summer 2020 all Public Sector old students will be automatically switched to new PIPFA Syllabus 2018 for Public Sectors as recommended by their respective departments.
2. The nominees of AGP, PMAD, PRAD and Treasury Department (PG) and other Government Organizations who registered **in** Winter Session 2018 will appear under PIPFA New Syllabus 2018. Newly registered students of AGP, PMAD, PRAD and Treasury Department (PG) in Winter 2018 are not allowed to sit under PIPFA Public Sector Syllabus-2015.
3. The nominees of CGA, CDA and LFA (PG) will appear in the examinations as per their existing arrangements (Old Syllabus 2015) till the revision of their syllabus.

Note: The question papers of Business Laws and Taxation are set in accordance with the Laws and regulations effective as at proceeding 1st July for winter and summer examinations. (Ref: clause 4.6.1, Examination Scheme, PIPFA Career Plan available on PIPFA Official Website).


The dates of submission of Examination Forms for Winter Session 2018 have been extended by October 01, 2018 with normal fee. The new schedule for late submission of Examination Forms is as follows;
