

PMAD students who were registered in PIPFA (Public Sector) upto Summer 2018 and have already appeared in exam in any paper(s) under Syllabus 2015 but could not qualify, will be allowed to appear in PIPFA Exam in that paper(s) under PIPFA Syllabus for Public Sector 2015 till PIPFA Exam Winter 2019; failing which they would automatically stand switched over to PIPFA Syllabus for PMAD-Winter 2019.
- 4. PMAD students who were registered in Winter-2018 and Summer-2019 (only) and have passed Database Management System (DBMS) and Performance Auditing (PA) in Summer Exam-2019, will not require to appear and pass the newly introduced paper of Public Finance (Level-3) under revised PMAD syllabus 2019. Such students will be required to pass their remaining papers under PIPFA Syllabus for PMAD-Winter 2019 to complete PIPFA qualification.
- 5. PMAD students who were registered in Winter-2018 and Summer-2019 (only) and have passed <u>either</u> Database Management System <u>OR</u> Performance Auditing in Summer Exam-2019 may avail any one of the following options:
 - a. Can switch to PIPFA Syllabus for PMAD Winter 2019 and appear in the paper of Public Finance by receiving coaching in that subject.
 - b. Can appear and pass in their failed paper of Database Management System (DBMS) <u>OR</u> Performance Auditing (PA) in two attempts. However, if they failed to pass Database Management System (DBMS) <u>OR</u> Performance Auditing (PA) till Summer 2020, they will be required to appear and pass the paper of Public Finance to complete PIPFA qualification.

(Note: PMAD students, registered in Winter 2018 and Summer 2019, opting to Public Finance or Database Management System or Performance Auditing are strictly advised to tick the option on the Exam Form carefully and clearly otherwise institute will not be responsible for any discrepancy)


- 6. PMAD students who are registered in Winter 2019 will appear under PIPFA syllabus for PMAD Winter 2019.
- 7. Course Contents and Syllabus Grids of Internal Audit Framework, Military Accounting Procedure, Pay, Pension & T.A. Rules and Store Accounting & Contract Evaluation have been revised and applicable to all students registered from Winter 2018 onward.
- 8. The paper of Audit Assurance (PS) will be without books from Winter 2019 onwards for PMAD students under new syllabus 2019.



- 6. Exemptions of those students who were registered upto Winter 2018 will be regulated under PIPFA Syllabus 2015.
- 7. Failed students registered upto Winter 2018 Exam would be allowed to appear according to the PIPFA Syllabus 2015 upto Winter 2019 Exam in their failed subject(s) only. Thereafter they would automatically stand switched over to PIPFA Syllabus 2019 from Summer 2020 and the above-mentioned Equivalency Schedule would apply to them.
- 8. Students who have received coaching of any subject(s) under the PIPFA Syllabus 2015 but have not yet appeared in PIPFA exam would be examined under PIPFA Syllabus 2015 in that subject(s). This facility would be available to them upto Winter 2019 Exam. From Summer 2020 Exam, they would automatically stand switched over to the PIPFA Syllabus 2019.
- 9. Those who are still in pipeline of coaching, their further coaching and examination would be according to the PIPFA Syllabus 2019.
- 10. Students who have already completed coaching of any level(s) under the Syllabus 2015, coaching of which has already been received by student, coaching of such additional subject(s) would be received by that student and such student would be examined by PIPFA in collaboration with Provincial Directorate, Local Fund Audit department jointly. On passing such subject(s), he/she would be awarded the participation certificate by PIPFA Lahore.
- 11. The students of LFA department appearing under new syllabus are advised to consult the circular dated March 12, 2019 for examination arrangements for Summer 2019 and Winter 2019.

1. Paper of FAM has been re-named as Audit and Assurance (PS) for all branches of Public Seg

- 3. If a trainee has passed any level prior to Winter 2018 Syllabus, he/she would be deemed passed relevant level in the new syllabus as well.
- 4. The trainees require passing their remaining papers for completing PIPFA qualification must follow the PIPFA Syllabus for Treasury Department 2018.
