Notification

PIPFA Examinations Summer 2020

In continuation of our earlier notices dated March 16th, April 06th and updates on 29th June, 2020, all students of Corporate and Public Sectors (AGP, CGA, PG, PMAD, PRAD, WAPDA and other Government Organizations) are informed that though PIPFA had planned to conduct Examinations to save the precious time of its students but it was dependent on government's decisions for relaxing or lifting the lockdown or allowing the gatherings. The latest announcement of Federal Education Minister regarding reopening of educational institutes/universities from September 15th in consultation with all stakeholders, has made the Board of Governors, PIPFA to review the feasibility of conducting exams or canceling the Summer-2020 attempt.

The Board of Governors, in its 133rd meeting, has decided to cancel the Written Examinations (only) for Level 3, 4 and Public Sector specific papers of Level 1 & 2, required to be conducted in written mode. However, Computer Based Examinations of Level 1 and 2 (common papers of Corporate & Public Sectors) will be conducted in September 2020, either through online mode or Remote Access. Fees and forms submitted for Quarterly CBE Summer-2020 have already been transferred to September-2020 attempt. For facilitating the students, the Board has decided to;

1. Carry forward the Examination Fee of Written Examinations (only) for Level 3, 4 and Public Sector specific papers of Level 1 & 2 of registered examinees of Summer 2020 to succeeding examination only;
2. Allow refund of Examination fee, if any registered examinee of Summer 2020 session wish to withdraw its enrolment of Summer 2020;
3. Lift the restriction of number of sitting papers for November attempt only. Registered Examinees of Summer 2020, who already submitted the Exam forms may add more papers in Winter Exam-2020 by login at students' Portal (students.pipfa.org.pk) on payment of exam fee for additional papers. The restriction of **Five (05)** papers (for Corporate Sector) and **Six (06)** papers (for Public Sectors) in one sitting has been lifted for Winter Examinations-2020 only.

Winter Examinations-2020 will be conducted as per schedule. Forms submission for Winter Examinations-2020 will be started from 18th August, 2020, as per defined schedule. The examinees, already registered for Quarterly CBE in Feb-March and students who were likely to appear in May-June and July-August can register themselves for September CBE, subject to completion of coaching of respective subject. The students are advised to follow the Institute's official communications, posted on website or through email only.

We pray for the health and safety of our students.
